### **ABSTRACT**

TSTRANSCO – Regulation – Contribution of One Day's Basic Pay + DA from employees, One Day's Basic Pension + DR from the pensioners and One Day's Remuneration from Artisans of TSTRANSCO, TSGENCO & TSDISCOMs for donating to the flood victims of Kerala State – Recovery from the salary/pension/remuneration for the month of August'2018 payable in September'2018 – Deduction – Orders – Issued.

### **ORDER:**

In the reference 1<sup>st</sup> cited the Telangana State Power Employees Joint Action Committee (TSPEJAC) have offered their willingness for contribution of one day's salary / pension from the employees/pensioners respectively of all TS Power Utilities for donating to the flood victims of Kerala State.

2. In the reference 2<sup>nd</sup> and 3<sup>rd</sup> cited, the State General Secretary, Telangana Raastra Vidyuth Karmika Sangam (Regd.No.H-58/2005) and Secretary General, Telangana Electricity Engineers' Association (Regd.No.319/07) have offered their willingness for contribution of One Day's Basic Pay from the salaries of the Employees of all TS Power Utilities for donating to the flood victims of Kerala State and also requested to examine to depute the electricity restoration teams from TSDISCOMs to Kerala State.

3. In the reference 4<sup>th</sup> cited, the President, Telangana Vidyut Contract Employee's Union (Regd.No.H-52/2015/TS) have offered their willingness for contribution of One Day's Remuneration from the Artisans of all TS Power Utilities to the flood victims of Kerala State.

4. After careful consideration, TSTRANSCO directs all the Pay Drawing Officers of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL to deduct One Day's Basic Pay + DA from employees, One Day's Basic Pension + DR from the pensioners and One Day's Remuneration from Artisans (rounded off to the nearest rupee) from the salary/pension/ remuneration of August'2018 payable in September'2018 to donate the same to the flood victims of Kerala State.

5. The following working instructions are issued to all the Drawing Officers of TSTRANSCO to follow scrupulously:

- a. Deduct One Day's Basic Pay + DA from the employees, One Day's Basic Pension + DR from the pensioners and One Day's Remuneration from the Artisans of TSTRANSCO.
- b. The amount of deduction shall be rounded off to the nearest rupee.
- c. The deduction shall be effected from the pay bill of August'2018 payable in September'2018 by preparing necessary schedules for each pay bill.
- d. The total amount thus recovered from each of the employee/ pensioner / Artisans shall be credited to the Head of Accounts of Chief Minister's Relief Fund for Flood Victims A/c.No.440402.

- e. The amount so credited is to be shown distinctly in the trial balance without clubbing with other remittances. The employee / pensioner / Artisan wise details of recovery schedule duly tallying with the amount shown in trial balance is to be furnished along with the Trial Balance.
- f. If any employee's/pensioner's/Artisan's contribution could not be recovered from August'2018 bills for the reasons such as non-drawl of Salary/Pension/Remuneration, the contribution shall be recovered from the next immediate duty pay bill invariably.
- g. The recovery particulars indicating the name of Employee / Pensioner / Artisan, Designation and amount particulars may be furnished to Pay Officer/ TSTRANSCO, O/o Executive Director (Finance), TSTRANSCO.

6. The Chairman & Managing Directors / TSGENCO, TSSPDCL & TSNPDCL are requested to issue necessary instructions to all the Drawing and Disbursing Officers under their control for effecting recovery of One Day's Basic Pay + DA from employees, One Day's Basic Pension + DR from the pensioners and One Day's Remuneration from Artisans (rounded off to the nearest rupee) from the Salary/Pension/Remuneration of August'2018 payable in September'2018 for donating the same to the flood victims of Kerala State. The Pay Officers of TSGENCO, TSSPDCL & TSNPDCL are requested to obtain the details as mentioned at para 5 (g) and send a consolidated cheque directly in favour of "Pay Officer, TSTRANSCO" alongwith recovery particulars, so as to remit the same in favour of "Chief Minister Relief Fund, Government of Telangana" on behalf of TS Power Utilities.

7. Accordingly, TSTRANSCO is hereby accords administrative sanction for an amount of Rs.9,00,00,000/- (Rupees Nine crores only) towards payment of donation to the flood victims of Kerala State on behalf of Employees/Pensioners/Artisans working in TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL. The Pay Officer/TSTRANSCO/VS/Hyderabad is authorized to claim an amount of Rs.9,00,00,000/- (Rupees Nine crores only) on behalf of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL and credit to the following head of account exclusively for relief of flood victims of Kerala State, duly informing the same to the Principal Secretary to Government, Revenue (CMRF) Department, Principal Secretary to Government, Finance Department & Special Chief Secretary to Government, Energy Department, Telangana State Secretariat, Hyderabad without fail:

**"MH 8443 – Civil Deposits  
800 – Other Deposits  
SH(02) – Chief Minister's Relief Fund"**

8. Further, the Pay Officer/TSTRANSCO is directed that after receipt of recovery particulars from all the TS Power Utilities, the excess amount recovered if any, the same shall be remitted to the head of account as specified at para-7. In case any shortfall, the same shall be distributed equally among all TS Power Utilities, duly preferring the claim towards reimbursement of shortfall amount from the respective power utility.

9. This order is issued with the concurrence of Joint Managing Director (Fin, Comml., & HRD) vide Regd.No.3792 dt.24-08-2018.
