**ORDER:**

In the reference 4<sup>th</sup> cited, the Director, CARE Hospitals, Banjara Hills, Hyderabad has preferred (2) No. credit medical bill amounting to Rs.4,93,000/- (Rupees Four Lakhs and Ninety Three Thousand only) towards the medical treatment to extended to Sri Kathalappa, LMD (Retd), ID.No.6501230, O/o SE/OMC/Metro-West/Hyderabad, as in-patient from 30.12.2022 to 07.01.2023 and 18.01.2023 to 30.01.2023 for “Multifactorial Encephalopathy, Aspiration Pneumonia, K/C/O DM, HTN,CVA-Left Hemiparisis, Acute CVA, Infection Sepsis” at CARE Hospitals, Banjara Hills, Hyderabad and requested to issue a cheque in favour of “Quality Care India Limited”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the JMD(HRD) hereby accords sanction for an amount of Rs.4,69,494/- (Rupees Four Lakhs Sixty Nine Thousand Four Hundred and Ninety Four only) for reimbursement of medical charges to CARE Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.23,506/- (Rupees Twenty Three Thousand Five Hundred and Six only) towards the excess amount claimed by CARE Hospitals, Banjara Hills, Hyderabad.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.4,69,494/- (Rupees Four Lakhs Sixty Nine Thousand Four Hundred and Ninety Four only) from SFMS F.Y. 2022-2023 & general ceiling to Quality Care India Limited against their credit bills under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.4,59,421/- is sanctioned to Sri Kathalappa, LMD (Retd), ID.No.6501230, O/o SE/OMC/Metro-West/Hyderabad. A sum of Rs.10,073/- is recoverable from the Pensioner. The SE/OMC/Metro-West/Hyderabad is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)/TSTransco within a month from the last date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
