After careful Consideration and detailed deliberations in TSTRANSCO Board meeting held on 17.03.2022, Board has accorded an approval for enhancement of delegation of powers to Chief Engineer/IT from Rs.1,00,000/- to Rs.2,00,000/- to attend the emergency procurement of computer related equipment and works for the items 5 & 6 of the table against clause 10.2 of purchase manual.


