**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Omega Hospital, Banjara Hills, Hyderabad has preferred (5) No. credit medical bill amounting to Rs.4,26,735/- (Rupees Four lakhs twenty six thousand seven hundred and thirty five only) towards the medical treatment extended to Smt.M.Mallamma, W/o.Late Ganga Ram, LI/Retd., ID.No.6600959, O/o.SE/OMC/Metro-Central/Hyderabad for the period from 31.12.2020 to 11.03.2021, 27.01.2021, 10.02.2021, 17.02.2021 and 24.02.2021 for “IGRT & Ca.Tongue Chemotheray (MM)” and requested to issue cheque in favour of Omega Hospitals.

2. After careful examination and as per Medical Regulations 4(f) &9(2) of A.P.S.E.Board as adopted by TSTransco, the Joint Managing Director (Finance, Commercial & HRD) as per delegation of powers orders in T.O.O.Ms.No.301, dt.31.3.2009, read with Memo dt.22-10-2020, the hereby accords sanction for an amount of Rs.4,26,735/- (Rupees Four lakhs twenty six thousand seven hundred and thirty five only) to Omega Hospital, Banjara Hills, Hyderabad full and final settlement of credit bills towards the medical charges.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.4,26,735/- (Rupees Four lakhs twenty six thousand seven hundred and thirty five only) to Omega Hospitals against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.4,25,705/- is sanctioned to Smt.M.Mallamma, W/o.Late Ganga Ram, LI/Retd., ID.No.6600959, O/o.SE/OMC/Metro-Central/Hyderabad. A sum of Rs.1,030/- is recoverable from the Pensioner. The SE/OMC/Metro-Central/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
