**ORDER:**

In the reference 2<sup>nd</sup> cited, the Chief Engineer, Warangal Zone informed that Sri.E.Sridhar, (Emp Id:1072358) S/o.Malliah, AE/Hotlines/Seetharampatnam was met with fatal electrical accident on 220 KV Bus at 220 KV SS Manuguru and expired on 28.09.2020.

2. In Lr.dt.03.11.2020, the Superintending Engineer/OMC/Khammam, forwarded the representation of Smt.S Sireesha, W/o.Late Sri E Sridhar, AE along with Death Certificate, Affidavit, Legal Heir and requested for payment of ex-gratia and providing employment under compassionate grounds. The request was put up to Board Meeting. The Board examined the request and after noting that there is no sufficient insurance coverage for Engineers/O&M staff working in hotlines branch, which is a specialized job has agreed to enhance the present insurance coverage to Rs.50 Lakhs (Rupees Fifty Lakhs Only) prospectively.

3. In the 39<sup>th</sup> Board meeting of TSTRANSCO held on 17.11.2020 the issue of sanctioning ex-gratia was discussed and decided to sanction Rs.25 lakhs as ex-gratia to dependent family members of Late Sri E.Sridhar, (Emp Id:1072358) AE (Elecl.)/ Hot lines Seetharampatnam, as a special case.

4. Accordingly, TS Transco hereby accords sanction for a sum of Rs.25,00,000/- (Rupees Twenty Five Lakhs only) towards ex-gratia as a special case to Legal heir Smt.S Sireesha, W/o.Late Sri E Sridhar, AE/Hotlines/Seetharampatnam.

5. The Chief Engineer/Warangal Zone/TSTRANSCO/Warangal is requested to take necessary action subject to the following conditions.

- a) The payment should be made without admitting any legal liability.
- b) An undertaking from the legal heir of the deceased employee shall be taken to the effect that there shall be no further liability to TSTRANSCO.
- c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
- d) Compassionate appointment to the spouse shall be as per eligibility.

6. This order is issued with the concurrence of JMD (Finance, Comml., & HRD) vide Regd.No.4481, dt.26.11.2020.
