In the reference 4<sup>th</sup> cited, the Director, Aster Prime Hospital, Ameerpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.3,82,473/- (Rupees Three Lakhs Eighty Two thousand Four Hundred and Seventy Three only) towards the medical treatment to extended to Smt. P.Soma Lakshmi, W/o Sri. P.Venkataiah, R.O.(Retd), ID.No.6501165 O/o SE/OMC–Circle/Metro-West/ Hyderabad, as in-patient from 20.05.2023 to 14.06.2023 for “Chronic Pontine Hematoma (MM)” at Aster Prime Hospital, Ameerpet, Hyderabad and requested to issue a cheque in favour of “Sri Sainatha Multi Speciality Hospital Pvt. Ltd.”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the JMD(HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, hereby accords sanction for an amount of Rs.3,80,997/- (Rupees Three Lakhs Eighty thousand Nine Hundred and Ninty Seven only) for reimbursement of medical charges to Aster Prime Hospital, Ameerpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1476/- (Rupees One Thousand Four hundred and Seventy Six only) towards the excess amount claimed by Aster Prime Hospital, Ameerpet, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,80,997/- (Rupees Three Lakhs Eighty thousand Nine Hundred and Ninty Seven only) from general ceiling to Sri Sainatha Multi Speciality Hospital Pvt. Ltd, against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,76,087/- is sanctioned to Sri. P.Venkataiah, R.O.(Retd), ID.No.6501165 O/o SE/OMC–Circle/Metro-West/Hyderabad. A sum of Rs.4909/- is recoverable from the Pensioner. The SE/OMC/Central is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD) TSTransco within a month from the last date of recovery from the pension of the Pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.
