ABSTRACT

TSTRANSCO - Telecom - Provision of cell phones in CUG at EHT substations – Enhancement of price of the mobile phone instrument (handset) towards procurement for all 220KV/400KV Substations - Orders – Issued.

ORDER:

After discontinuation of usage of VHF sets, cellular connections are being provided in CUG at all EHT sub-stations of TSTRANSCO, where cell one coverage is available, duly permitting calls only within the group with the cost of cell phone instrument (handset) @Rs.2000/- each for use at the substations vide T.O.O cited above.

The Chief Engineer/Metro Zone, Hyderabad has submitted the proposals for enhancement of the price of the mobile phone instrument to at least Rs.7000/- per instrument towards procurement of smart phones in place of basic phones for all 220KV/400KV substations along with change of plan suitable for smart phones duly mentioning the reasons for requirement of smart phones in all 220KV/400KV substations viz to avoid considerable delay in furnishing of tripping information in Substations by the operators to the concerned staff.

After careful consideration of the proposals of Chief Engineer/Metro Zone, Hyderabad, TSTRANSCO hereby accords approval for the following.

1. To procure mobile phone instrument (handset) @ Rs.7000/- each for use only at 220KV/400KV Substations and @Rs.2000/- each for use at 132KV Substations.
2. To provide the CUG plan which is being implemented for employees at all 220KV/400KV Substations and CUG-70 plan at all 132KV Substations duly permitting the calls only within the group.
3. If any 400KV Substations is provided with 2Nos. cellular connections in CUG, only one mobile phone instrument will be procured @ Rs.7000/- and another will be with @Rs.2000/- only.

The mobile phone instrument may be replaced with new ones only after they have served their useful life, which is normally 3 years.

This order is issued with the concurrence of the Joint Managing Director (Finance, Comml., & HRD) vide Regd. No.4366, Dt. 27.10.2021.
