**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Krishna Institute of Medical Sciences, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.3,14,011/- (Rupees Three lakhs fourteen thousand and eleven only) towards the medical treatment extended to Sri R.Ram Das, Line Man (Retd.), ID.No.1048074, O/o.SE/OMC/Metro-West/Hyderabad as in-patient for the period from 08.10.2020 to 22.10.2020 for “Surgery – Anterior resection with ileostomy, Colectomy, Anastomosis & MM” at Krishna Institute of Medical Sciences, Secunderabad and requested to issue cheque in favour of Krishna Institute of Medical Sciences Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with Memo dt.22-10-2020, the Joint Managing Director (Finance, Commercial & HRD) hereby accords sanction for an amount of Rs.3,12,916/- (Rupees Three lakhs twelve thousand nine hundred and sixteen only) to Krishna Institute of Medical Sciences, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1,095 /- (Rupee One thousand and ninety five only) towards the excess amount claimed by Krishna Institute of Medical Sciences, Secunderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.3,12,916/- (Rupees Three lakhs twelve thousand nine hundred and sixteen only) to Krishna Institute of Medical Sciences Limited against their credit bills under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,99,435/- is sanctioned to Sri R.Ram Das, Line Man (Retd.), ID.No.1048074, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.13,481/- is recoverable from the pensioner. The SE/OMC/Metro-West/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD), within a month from the date of recovery from the salary of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
