ORDER:

In the reference 4th cited, the Director, Omega Hospital, Banjara Hills, Hyderabad has preferred (4) Nos. credit medical bills amounting to Rs.2,08,148/- (Rupees Two lakhs eight thousand one hundred and forty eight only) towards the medical treatment extended to Sri Mohd Sheikh Hassan, Artisan Gr-I, ID.No.2537 O/o.SE/OMC/Karimnagar from 25.10.2022 to 29.10.2022, 10.11.2022 to 14.11.2022, 28.11.2022 to 30.11.2022, 13.12.2022 to 16.12.2022 for “Ca.Sigmoid Colon for Chemotherapy Cycles I, II, III & IV” at Omega Hospital, Banjara Hills, Hyderabad and requested to issue cheque in favour of Hyderabad Institute of Oncology Pvt Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Joint Managing Director (Fin., Comml. & HRD) hereby accords sanction for an amount of Rs.2,05,148/- (Rupees Two lakhs five thousand one hundred and forty eight only) from SFMS 2022-23 for reimbursement of medical charges to Omega Hospital, Banjara Hills, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.3000/- (Rupees Three thousand only) towards the excess amount claimed by Omega Hospital, Banjara Hills, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,05,148/- (Rupees Two lakhs five thousand one hundred and forty eight only) from SFMS 2022-23 to Hyderabad Institute of Oncology Pvt Ltd. against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,01,160/- is sanctioned to Sri Mohd Sheikh Hassan, Artisan Gr-I, ID.No.2537 O/o.SE/OMC/Karimnagar. A sum of Rs.3988/- is recoverable from the Artisan. The SE/OMC/Karimnagar is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.
