ORDER:

In the reference 4th cited, the Director, Star Hospitals, Banjara Hills, Hyderabad has preferred (1) Nos. credit medical bill amounting to Rs.5,14,821/- (Rupees Five lakhs fourteen thousand eight hundred and twenty one only) towards the medical treatment extended to Smt G.Kalavathi M/o Sri G.V.Sagar Bhasker, DE ID.No.1060157 O/o.SE/OMC/Metro-Central/Hyderabad as in-patient for the period from 24.05.2019 to 26.07.2019 for “Chronic Kidney Disease, HTN, ESRD (Medical Management)” at Star Hospitals, Banjara Hills, Hyderabad and requested to issue cheque in favour of Star Hospitals, Banjara Hills, Hyderabad.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and vide T.O.O.Ms.No.110, dt.08-08-2016, the Chairman & Managing Director hereby accords sanction for an amount of Rs.5,14,821/- (Rupees Five lakhs fourteen thousand eight hundred and twenty one only) (i.e. Rs.1,12,158/- from General Ceiling and Rs.4,02,663/- from SFMS 2019-2020) for reimbursement of medical charges to Star Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.5,14,821/- (Rupees Five lakhs fourteen thousand eight hundred and twenty one only) (i.e. Rs.1,12,158/- from General Ceiling and Rs.4,02,663/- from SFMS 2019-2020) to Star Hospitals, Banjara Hills, Hyderabad against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.4,52,991/- is sanctioned to Sri G.V.Sagar Bhasker, DE ID.No.1060157 O/o.SE/OMC/Metro-Central/Hyderabad. A sum of Rs.61,830/- is recoverable from the employee. The SE/OMC/Metro-Central/Hyderabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
