ORDER:

In the reference 3rd cited, the Director, Star Hospitals, Banjara Hills, Hyderabad has preferred (2) Nos. credit medical bills amounting to Rs.2,58,278/- (Rupees Two lakhs fifty eight thousand two hundred and seventy eight only) towards the medical treatment extended to Sri K.Kumara Swamy, LM(Retd.) ID.No.6501206 O/o.SE/ OMC/Metro-West/Hyderabad as in-patient for the period from 09.07.2019 to 11.07.2019 for “Infective COPD Mild LV Dysfunction & Surgery – PTCA + Stents with extra Balloon” at Star Hospitals, Banjara Hills, Hyderabad and requested to issue cheque in favour of Unimed Health Care Pvt. Ltd.,

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and vide T.O.O.Ms.No.110, dt.08-08-2016, the Chairman & Managing Director hereby accords sanction for an amount of Rs.2,57,873/- (Rupees Two lakhs fifty seven thousand eight hundred and seventy three only) for reimbursement of medical charges to Star Hospitals, Banjara Hills.Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.405/- (Rupees Four hundred and five only) towards the excess amount claimed by Star Hospitals, Banjara Hills.Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,57,873/- (Rupees Two lakhs fifty seven thousand eight hundred and seventy three only) to Unimed Health Care Pvt. Ltd., against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.2,48,686/- is sanctioned to Sri K.Kumara Swamy, LM(Retd.) ID.No.6501206 O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.9,187/- is recoverable from the pensioner. The SE/OMC/Metro-West/Hyderabad is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
