After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and vide T.O.O.Ms.No.110, dt.08-08-2016, the Chairman & Managing Director hereby accords sanction for an amount of Rs.5,22,410/- (Rupees Five lakhs twenty two thousand four hundred and ten only) for reimbursement of medical charges to Krishna Institute of Medical Sciences, Minister Road, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.58,440/- (Rupees Fifty eight thousand four hundred and forty only) towards the excess amount claimed by Krishna Institute of Medical Sciences, Minister Road, Secunderabad.
