ORDER:

In the reference 4th cited, the Director, Yashoda Hospital, Somajiguda, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.4,03,004/- (Rupees Four Lakhs three thousand and four only) towards the medical treatment extended to Smt. M.Prameela, W/o. Sri M.Gopala Reddy, ADE/Retd, ID No.6501604, O/o.SE/OMC/Circle/Metro-Central/Hyderabad as in-patient for the period from 10.02.2023 to 22.02.2023 for “CKD on MHD, CVA, DM, HTN (MM)” at Yashoda Hospitals, Somajiguda, Hyderabad and requested to issue cheque in favour of M/s.Yashoda Super Speciality Hospital.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.3,98,348/- (Rupees Three lakhs ninety eight thousand three hundred and forty eight only) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bill towards the medical charges duly deducting an amount of Rs.4,656/- (Rupees Four thousand six hundred and fifty six only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.3,98,348/- (Rupees Three lakhs ninety eight thousand three hundred and forty eight only) (i.e. an amount of Rs.2,63,473/- from general ceiling & Rs.1,12,085/- from SFMS 2022-2023 to M/s.Yashoda Super Speciality Hospital against their credit bill under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.3,75,558/- is sanctioned to Sri M.Gopala Reddy, ADE/Retd, ID No.6501604, O/o. SE/OMC/Circle/Metro-Central/Hyderabad. A sum of Rs.22,790/- is recoverable from the Pensioner. The SE/OMC/Circle/Metro-Central/Hyderabad is requested to recover amount from the pension in installments accordingly and after recovery of the total amount intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TSTransco, within a month from the last date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
