## ORDER:

After careful examination and as per Medical Regulations 4(f) &9(2) of A.P.S.E.Board as adopted by TSTransco, the Joint Managing Director (Finance, Commercial & HRD) as per delegation of powers orders in T.O.O.Ms.No.301, dt.31.3.2009, read with Memo dt.22-10-2020, the hereby accords sanction for an amount of Rs.4,65,296/- (Rupees Four lakhs sixty five thousand two hundred and ninety six only) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.7,125/- (Rupees Seven thousand one hundred and twenty five only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.
