ORDER:

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad has preferred (1) No. credit medical bill amounting to Rs.2,29,116/- (Rupees Two lakhs twenty nine thousand one hundred and sixteen only) towards the medical treatment extended to Sri Syed Moulana, Artisan Gr-IV, ID.No.1450 O/o.SE/OMC/Adilabad as in-patient from 21.10.2021 to 29.10.2021 for “Bilateral MCA, Infarct with Hemmorrhagic Transformation MM” at Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Pvt. Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Joint Managing Director (Fin., Comm. & HRD) hereby accords sanction for an amount of Rs.2,24,155/- (Rupees Two lakhs twenty four thousand one hundred and fifty five only) for reimbursement of medical charges to Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.4,961/- (Rupees Four thousand nine hundred and sixty one only) towards the excess amount claimed by Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.2,24,155/- (Rupees Two lakhs twenty four thousand one hundred and fifty five only) to M/s.Yashoda Health Care Services Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidvut Soudha, Hyderabad.

4. An amount of Rs.2,01,271/- is sanctioned to Sri Syed Moulana, Artisan Gr-IV, ID.No.1450 O/o.SE/OMC/Adilabad. A sum of Rs.22,884/- is recoverable from the artisan. The SE/OMC/Adilabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
