Revised Administrative Approval – Extension of Power supply at 132 KV level to only one Pumping Station near Kannepalli village for a load of 18.86 MW by constructing 132/11 KV SS at Beersagar, connected line & Bay under Kaleshwaram Lift Irrigation Scheme in Jayashankar Bhupalapally District-Deposit Contribution Works- Accorded-Regarding.

## PROCEEDINGS:

- 1. TSTRANSCO(erstwhile APTRANSCO) has accorded Administrative approval vide T.O.Os 1<sup>st</sup> and 2<sup>nd</sup> cited for Bulk load and D.C works for the Extension of Power supply to 2 Nos Pumping Stations at 132 KV level for a load of 28.35MW-20MW –Pump House at Kannepalli and 8.35 MW-Pump House at Kataram under Kaleshwaram Lift Irrigation Scheme.
- As per the suggestion of Advisor/Lift Irrigation Scheme that supply to the Kataram Pump House can be extended at 33 KV level, this office vide Lr.No.CE(Proj-II)/SE(LI)/DE(LIS)/ADE2/D.No.80/2017,dt:27.01.2017 has informed CE/Projects/I&CAD / Karimnagar that it is not necessary to extend the power supply at 132 KV level to the Kataram Pump House and requested to contact NPDCL/Warangal and local DISCOM officials for want of power supply at 33 KV level. The revision of extension of supply to only Kannepalli Pump House necessitated to revise the Scheme for the subject Pumping station.
- 3. Simultaneously, the Chief Engineer/LIS/TSTRANSCO has awarded the subject contract and the works of 132/11 KV Substation at Beersagar near Kannepalli village were completed and charged on 30.06.2020.
- 4. After careful consideration, TSTRANSCO approves the Scheme at a cost of Rs.9.8962 Crores (Rupees Nine Crores Eighty Nine Lakhs and Sixty Two Thousand Only) for a load of 18.86 MW (2x8.1 MW+1x2.66 MW) towards construction of 132/11 kV Substation at Beersagar near Kannepalli Village for extension of Power Supply at 132 KV level to the Lift Irrigation Pumping Station near Kannepalli Village under Kaleshwaram Lift Irrigation Scheme as Deposit Contribution Works. The details of the scheme is as follows:

- 5. "In exercise of the powers conferred under section 164 of the Electricity Act,2003 Central Act No.36 of 2003, the Government of Telangana (vide G.O.Ms.No.115, Dt.7.10.2003) conferred upon the Transmission Corporation of Telangana Limited, the Transmission supply licensee in the state of Telangana and Northern Power Distribution Company of Telangana Limited, the distribution and retail supply licensee or their authorized representatives to have the powers for placing of the electric supply lines or electric plant for the transmission of electricity or for the purpose of telephonic or telegraphic communications necessary for the proper co-ordination of works that a telegraphic authority possessed under the provision of the Indian Telegraph Act, 1885 (Central Act 13 of 1885)."
- 6. The sanction accorded in Para No.4 above is subject to instructions issued by the TSTRANSCO on release of services and tariff as may be in force from time to time.
- 7. An amount of **Rs. 9.8962 Crores** shall be collected as Deposit from Engineer-in Chief / Kaleshwaram Project, I&CAD department.
- 8. The order is issued with the concurrence of the Joint Managing Director (Finance, Comml. & HRD )/ TSTRANSCO vide Regd.No.4134, dated:02.11.2020.
