#### **ORDER:**

In order to avoid over loading of Power Transformers, to meet the upcoming load demand, to maintain high efficiency and redundancy of Power Transformers, the proposals were received from the Chief Engineer/Zone/Metro, the Chief Engineer/Zone/Rural and the Chief Engineer/Zone/Karimnagar for augmentation of PTRs capacities at 132KV Mamidipally SS in Metro zone, 132 KV Jadcherla SS, 132 KV Munagala SS in Rural zone, 132 KV Domakonda SS and 132 KV Godur SS in Karimnagar Zone.

- 2) After careful examination, TSTRANSCO accords approval as detailed below:
- Administrative approval is accorded for the augmentation/deration of PTR capacities is proposed as follows so as to avoid the overloading of existing Transformers to avoid load relief / avoid power cuts and to meet the growing load demand, as detailed below:
