Augmentation of PTR capacities at 220/132 KV Manthani SS and 132/33 KV Kataram SS – Administrative Approval -Regarding.

ORDER:

The Load flow studies are carried out by the Power system wing for providing 24 Hrs supply to the Agricultural sector in the Telangana state. As per the studies, the 220/132 KV Manthani (2x100 MVA) have crossed 1x150.3 (MVA) loading under N-1 contingency. Accordingly, the Chief Engineer/ Karimnagar zone vide letter dated 04.07.2018 has submitted the Augmentation proposal for PTR Capacities at 220 KV Manthani SS from 2x100 MVA to 2x100 + 1x 160 MVA

- 2) Further, the Chief Engineer/Karimnagar zone vide letter Dt:29.07.2018 has submitted the Augmentation proposal of PTR Capacity at 132 KV Kataram SS from 1x50 + 1x31.5 MVA to 2x50 MVA, in view of arranging feasibility of 9 MVA, by arranging separate 33KV Bay extension for Kaleshwaram LIS stage-2 Pump House at 132/33 KV Kataram SS to TSNPDCL.
- 3) After careful examination, TSTRANSCO accords approval as detailed below:
- a) The Augmentation of PTR capacities at 220/132 KV Manthani SS and 132/33 KV Kataram SS are as follows:

- b) The Chief Engineer/Karimnagar zone is authorized to execute the works by calling open tenders, as per the departmental procedures in vogue, duly utilizing centralized equipment/materials from TLC Stores/Erragadda.
- c) The FA&CCA(Accounts) shall be arrange for funding tie-up with financial Institutions/Banks for the above works.

- d) The FA&CCA (Accounts) shall allocate the Capital budget from TSTRANSCO funds in the **FY 2020-21**, till funding tie-up works finalised, so as to avoid SAP process problems, against the Scheme code created in SAP.
- e) The Chief Engineer / Transmission shall provide the scheme code and Capital budget for the subject scheme in SAP during the **FY 2020-21.**
- f) The Chief Engineer/P&MM shall procure the PTRs along with associated equipment / material, required for the Augmentation works.
- g) The scheme shall be taken up during 2020-21.
