ORDER:

These 3441 posts are being added to the cadre strength after allocation/Fixation of headquarters in phased manner as per the requirement.

2. In the references 3<sup>rd</sup> to 9<sup>th</sup> cited, orders were issued for allocation of 1801 new posts in various cadres and it was also ordered therein that the allocation of the remaining new posts will be issued separately in phased manner as per the requirement.
