

## ABSTRACT

TSTRANSCO – Regulations – Amendment to Annexure III & VI of the APSEB Service Regulations as adopted by TSTRANSCO – Induction of Proficiency in Office Automation with usage of computer and Associated Software Test at CTI/TSTRANSCO for appointment by transfer to the post of Jr.Assistant cum Computer Operator in Accounts Service and Assistant cum Computer Operator in P&G Services –Orders - Issued.

### **ORDER :**

In the TOO 4<sup>th</sup> cited an amendment was issued to the APSEB Service Regulations Part-III, Annexure-III & VI for Direct Recruitment/ Appointment by Transfer to the post of Assistant Cum Computer Operator in P & G Service and creation of post of Junior Assistant Cum Computer Operator in Accounts Service by omitting the existing posts of Assistant & Typist in P&G Service, Jr.Assistant (LDC) & Typist in Accounts Service by prescribing the additional qualifications and tests for promotion to the next higher cadres for in-service employees.

2. In T.O.O. 4<sup>th</sup> cited, it was also ordered that the employees who seeks appointment by transfer from O&M and other services, shall have (1) in possession of Degree of any recognised University (2) Must have pass Certificate Course in Computer Application/Office Automation (MS-Office) offered by the Institutions recognised by the Government of Telangana or Government of India and established in the State of Telangana.

3. As per the minutes of 28<sup>th</sup> Board Meeting held on 23-05-2018, in T.O.O. 6<sup>th</sup> cited partial modification orders to the T.O.O. 4<sup>th</sup> cited were issued and ordered that the Typist/Jr.Assistant /Assistant are redesignated as Jr.Assistant cum Computer Operator in Accounts Service and Assistant cum Computer Operator in P&G Service and are exempted from possessing additional qualifications as prescribed in TOO 4<sup>th</sup> cited for promotion to the next higher cadre and also to those who crossed the age of 45 years for considering under unqualified slot subject to fulfilling the eligibility criteria for promotion to the next higher cadre prescribed prior to issuance of T.O.O. (Jt.Secy-Per) Ms.No.166 dt.08.11.2017.

4. In the TSPCC Meeting held on 20.04.2021 the issue of Non considering the conversion from O&M and other services to Jr.Assistant Cum Computer Operator cadres for want of computer certificate who have already passed screening test and obtained no objection certificate, was discussed and decided to conduct "Proficiency in Office Automation with usage of computer and Associated Software Test" at CTI, TSTRANSCO in lieu of pass Certificate Course in Computer Application/Office Automation (MS-Office).

5. After careful examination, TSTRANSCO hereby issues the following amendments to the Annexure III & VI in part-III of the APSEB Service Regulations as adopted By TSTRANSCO:

### AMENDMENT-I

Under column (4) against the category 4 (b) (Assistant cum Computer Operator) under the main heading APSEB Service Regulations Part-III and sub-heading Class-III of Annexure-VI to the post of Assistant cum Computer in P&G Service:
