PENSIONS – TSTRANSCO – Sanction of Revised Pension and Dearness Relief to all Pensioners and Family Pensioners as on 01.04.2018 – Orders – Issued.

**ORDER:**

In the TOO 4<sup>th</sup> cited, TSTRANSCO revised the existing Pension/Family Pension/Compassionate Pension/ Compassionate Allowance or Consolidated Pension that is being drawn in pre-revised scales of 2014 was consolidated duly merging the Dearness Relief on Pension as on 01.01.2014 and 30% fitment benefit + additional fitment of 7.5% i.e., 37.5% of the said basic pension has been revised consolidated pension to Pensioners/Family Pensioners and it was also ordered that the revised consolidated pension shall come into force with effect from 01.04.2014.

2. In the TOO 4<sup>th</sup> cited, TSTRANSCO issued orders in continuation to the orders at reference 2<sup>nd</sup> and 3<sup>rd</sup> cited, ordering that Minimum Pension shall be fixed at Rs.7,488/- per month with effect from 1-4-2014. It was also ordered therein that if the revised consolidated basic pension / revised consolidated basic family pension falls short of Rs.7,488/-, the same shall be raised to Rs.7,488/- per month.

3. In the TOO 6<sup>th</sup> cited, Pay Revision Negotiating Committee'2018 was constituted to make a thorough study and submit its recommendations on the Revision of Pay and Allowances to all categories of Employees and Pensioners of TS Power Utilities.

4. The Joint Negotiation Committee of All Pensioners' Associations of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL and various employees Unions and Associations have represented for Revision of Pension allowing the same percentage rate of fitment benefit that allowed to the Employees of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL while revising their Pension/Family Pension / Compassionate Pension / Compassionate Allowance or Consolidated Pension and also requested for sanction of Additional percentage as provided earlier.

5. The Pay Revision Negotiating Committee'2018 submitted its report recommending that the Fitment Benefit allowed to the employees of TS Power Utilities may be considered depending upon the commitment and also recommended that in case, service weightages are extended to employees, the pensioners may be allowed additional 7.5% over and above regular fitment, in lieu of service weightages.

6. In the TOOs 8<sup>th</sup> and 9<sup>th</sup> cited orders were issued revising the Scales of Employees of TSTRANSCO. The DA appropriate to the basic pay at the rates as on 01-01-2018 and 35% of basic pay were merged with basic pay on the date of option of the employees for the purpose of fixation of their pay in the Revised Pay Scale'2018.

7. After careful consideration, TSTRANSCO directs that the existing Pension / Family Pension / Compassionate Pension / Compassionate Allowance or Consolidated Pension that is being drawn in Pre Revised Scales of 2018 shall be consolidated duly merging the Dearness Relief on Pension as on 01-01-2018 and a fitment of 35% fitment + additional fitment of 7.5% i.e., 42.5% of the said basic pension shall be the revised consolidated pension to Pensioners / Family Pensioners. The Revised Consolidated Pension shall come into force w.e.f. 01-04-2018.

8. The TSTRANSCO further directs that as per the orders issued vide TOOs 2<sup>nd</sup> to 4<sup>th</sup> cited, the Minimum Pension is fixed at Rs.11,688/- per month w.e.f. 01-04-2018. If the Revised Consolidated Basic Pension / Revised Consolidated Basic Family Pension falls short of Rs.11,688/- per month, then the minimum pension of Rs.11,688/- per month shall be paid.

9. The TSTRANSCO also directs to pay a sum of Rs.1350/- (Rupees One thousand three hundred and fifty only) per month as Medical Allowance to all the Pensioners and Family Pensioners with effect from 01.04.2018 as follows:

- (i) The Pensioner who is in receipt of Service Pension and Family Pension (both) is eligible to draw Single Medical Allowance of Rs.1350/- per month.
- (ii) The Family Pensioner who is employed on compassionate grounds and in receipt of Medical Allowance shall be allowed to exercise his/her option whichever is advantageous to him/her for claiming monthly Medical Allowance.

10. While calculating the percentages increase in Basic Pension/Consolidated Pension the part of rupee so arrived shall be rounded to the next higher rupee.

Applicability: The consolidated pension ordered above shall apply to:

- i) All TSTRANSCO, TSGENCO and Two DISCOMS (viz., TSSPDCL & TSNPDCL) Pensioners in respect of Service Pension/Family Pension under APLP Rules, 1961, APGS Family Pension Rules, 1964 and Liberalized Pension Regulations.
- ii) Pensioners covered by A.P.Revised Pension Rules, 1980 as adopted and
- iii) Who retired or died prior to 01.04.2018.

11. The above Consolidated Pension will be worked out with reference to the un-commuted Pension. Such commuted portion of Pension should be deducted from the Consolidated Pension while making monthly disbursement.

12. At the time of noting Consolidated Pension on the Pension Payment Orders, the Pension Disbursing Officer shall simultaneously calculate and note corresponding consolidated enhanced Family Pension and consolidated normal Family Pension on the Pension Payment Order. Similarly, in case where enhanced family pension is being drawn, the normal family pension to be drawn in future would also be consolidated and noted on the Pension Payment Order.

13. In respect of the Pensioners and Family Pensioners who are re-employed, the Dearness Relief as on 01.01.2018 and 42.5% (35% Fitment Benefit + 7.5% Additional Percentage) increase in basic pension which would have been admissible to them but for their re-employment/employment shall be merged with basic pension with effect from 01.04.2018. The pay drawn by the re-employed pensioners during the period of re-employment shall also be re-fixed taking into account the enhanced revised pension.

**14. Applicability of Dearness Relief:**

The Dearness Relief for the Pensioners who retired/died before 01.04.2018 to whom the Consolidated Pension now ordered above is applicable will be regulated half yearly (on 1<sup>st</sup> January and 1<sup>st</sup> July) and will be regulated with reference to the All India Price Index (proceeding 12 months moving average), as per the formula given below:

$$\text{New DR} = \frac{\text{C1-CO}}{\text{CO}} \times \text{Pension/Consolidated Pension}$$

Where:

$$\text{CO} = \text{Index on 01-01-2018}$$

$$\text{C1} = \text{Index on the date on which DR is proposed to be revised.}$$

For this purpose index means preceding 12 months moving average of All India Consumer Price Index.

(While calculating the Dearness Relief the fraction of Rupee shall be rounded to the next higher rupee)

The new Dearness Relief with effect from 1-7-2018 shall be @ 2.135%

15. The fixation benefits as per these orders shall accrue from 1-4-2018 shall be paid in cash in Five (5) equal monthly installments commencing from 01-10-2018 pension.

16. **Restriction on Commutation:** The Pensioners are not entitled to commute any portion of the difference in pension now admissible as per these orders.

17. All Pension Disbursing Officers/Pension Payment Officers are requested to implement these orders without any authorization of Audit Officer specified in item 7 of Annexure to B.P.Ms.No.501, Dt.19.05.1989.

18. These orders are issued with the concurrence of Jt.Managing Director (Finance, Comml., & HRD)/TSTRANSCO vide Regd.No.3954, Dt.05-09-2018.
