ORDER:

As per the SRPC 118th OCC meeting held on 11.04.2016, SEMs have to be provided for all the interstate lines. Further, the minutes (**4.15**) of 32nd Commercial Sub-committee meeting (SRPC) held on 17.10.2016, are as follows:

- "4.15. PGCIL informed that based on the requirement and commitment by utilities they can procure the meters and hand over to them. Further, PGCIL informed the forum that the commitment of PGCIL would be up to the procurement only and the ownership. Installation and O&M to be done by the respective utilities".
- 2) M/s. PGCIL vide reference Dt: 20.03.2018 has informed that the procurement of SEMs and its installation/Maintenance is the responsibility of individual power utilities.
- 3) As per the SRPC guide lines, the Chief Engineer / 400KV, the Chief Engineer / Projects -II and the Superintending Engineer / Construction have furnished various proposals for procurement to the Chief Engineer / Transmission for 25 Nos. SEMs with 19 Nos. Data collection devices, for the interstate lines works related to them.
- 4) After careful examination, TSTRANSCO accords approval as detailed below:
- a) The Chief Engineer / P&MM shall procure 25 Nos. SEMs with 19 Nos. Data collection devices for interstate lines for energy measurement.
- **b)** The FA & CCA (Accounts) & CFO shall allocate an amount of Rs. **9,57,747.00** /- under Non-Plan capital Budget for procurement of 25 Nos. SEMs with 19 Nos. Data collection devices, in the pay unit code 9200 i.e Pay Officer / Vidyut Soudha / Hyderabad during FY: 2018-19.
- 5) This order is issued with the concurrence of the Joint Managing Director (Fin., Comml. & HRD) vide Regd. No. 3279, Dt: 28.07.2018.
