ORDER:-

In the reference 2nd read above, amendment orders were issued in reservation of posts in favour of Persons with Disabilities and Interchange among the 3 categories of Disabled Persons in direct recruitment in accordance with PWD Act, 1995, substituting the items (a) to (d) with items (a) and (b), leaving the items (c) and (d) to illustration I for Para 6 (iv) of orders issued in G.O.Ms.No.23, WCD & SC (DW) Department, dated: 26.05.2011.

2. After careful examination of the matter, the following corrigendum is hereby ordered to the orders issued in G.O.Ms.No.6, WCD & SC Department, Dated: 12.04.2016 wherein the illustration I of para 6 (iv) of G.O.Ms.No.23, Department for WCD & SC, dated: 26.05.2011, was amended substituting the items (a) to (d) of illustration I under para 6 (iv) of the above G.O. with items (a) & (b) only leaving the item (c) & (d).

Corrigendum

In the said G.O. items (a) to (d) of illustration I for para 6 (iv) shall be substituted with the following namely:-

- a) In the case of 6th Roster point fixed for Blindness or Low vision (women), if woman candidate with Blindness or low vision is not available in the initial recruitment year, the vacancy shall be filled up by the male candidates with blindness or low vision without carrying the vacancy forward to the next year. If women or male candidates with blindness or low vision are not available in the initial recruitment year, the vacancy shall be carried forward to the succeeding recruitment year for being filled up firstly by Women with Blindness or Low vision.

- b) If women with blindness or low vision in that succeeding recruitment year are also not available, the vacancy shall be filled up by the male candidates with blindness or low vision. If women or male candidates with blindness or low vision are not available in such succeeding recruitment year also, the post may first be notified for Hearing Impaired candidates (being next category in the roster and if no such candidates comes forward it may be notified for locomotor Disability or cerebral palsy (being the next category in the roster).
- c) Only when there is no person with disability of any of the three categories available for the post, the employer shall fillup the vacancy by appointment of a person other than a person with disability.
- d) For the other roster points reserved for women for remaining two categories of disability i.e. roster points 131, 256 the same procedure explained at (a) to (c) above shall be followed.
2. The General Administration (Ser.D) Department shall issue necessary amendments to the Telangana State & Subordinate Service Rules, 1996 accordingly.
3. All the Department of Secretariat, Heads of Departments and all officers concerned are requested to implement the above orders.
