ORDER:

- Presently in the 220/132KV Sub-stations towards fire safety only fire Cylinders are existing. It is proposed to construct a water sump of 1.00 Lakh Liter Capacity and providing necessary jockey pumps and booster pump arrangements to maintain required pressure to control fire.
- 2. Accordingly, review meeting was held on 11.05.2022 with Chief Engineer/ Zones and following proposals are made:
 - ❖ There are total 98Nos. 220/132KV and 247Nos. 132/33KV Substations are existing in the Telangana. Now, it is proposed to establish fire safety for the important substations where the substations are located nearby houses or important Substations to avoid fire accidents. In the first phase programme, the number of substations to be established with fire safety are listed below:-
