ORDER:

1. The Chief Engineer/Rural has stated that in the 220kV SS Narketpally the existing BT road is laid at the time of construction of the Sub-station i.e., in the year 1999 (March). The sub-station is situated adjacent to Hyderabad-Vijayawada Highway. The existing BT surface of the road is completely damaged due to wear and tear and there is no proper approach to main gate, Control house and 160 MVA PTR's area. Hence it is proposed to lay CC road.
2. Accordingly, the Chief Engineer/Rural Zone has submitted an estimate for the work of “Laying of CC Road from Main Gate to Control House and in between the 220kV and 132kV switchyard (PTR's) area at 220/132/33kV SS Narketpally in Nalgonda District” and the same was scrutinized and the value of work comes to Rs. 33,00,000.00 (Rupees Thirty Three Lakhs only)
3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TS Transco here by accords approval for taking up the work of “Laying of CC Road from Main Gate to Control House and in between the 220kV and 132kV switchyard (PTR's) area at 220/132/33kV SS Narketpally in Nalgonda District” for an amount of Rs. 33,00,000.00 (Rupees Thirty Three Lakhs only) including Corpus Fund and GST Provisions.
4. The work will be taken up after allocation of necessary capital budget (Non-Plan) and sanction of the estimate.
