ORDER:

- 1. The premises of Vidyut Soudha is provided with both internal & external Fire Fighting system. At present 6 Nos fire personnel are working to maintain the firefighting system in Vidyut Soudha.
- The six leading Firemen are attending duties in 3 shifts, 2 in each shift.
 Nos retired fire personals submitted their willingness to work in TS TRANSCO for the post of firemen (Retired).
- 3. A note was circulated to the board by Superintendent of Police/ Vigilance/TS TRANSCO/Vidyut Soudha/Hyderabad to accord approval for engaging of additional (01) No Retired Fire Personnel in addition to 6 leading firemen (LFM) to maintain the both External & Internal Firefighting system in Vidyut Soudha stating that it is becoming difficult to give weekly off to the existing firemen.
- 4. TS TRANSCO examined the issue in detail and approved to engage 1 No Leading Fire Man (LFM) in addition to the existing 6 Nos leading firemen on contract basis till 9th August -2023 by paying consolidated monthly pay of Rs.20,000.00 (Rupees Twenty Thousand Only) per month.

- 5. The Consolidated Monthly Pay to be paid to the leading Fire Man (LFM) shall be shared equally TS TRANSCO and TS GENCO.
- 6. The Pay Officer/TS TRANSCO/Vidyut Soudha/Hyderabad is directed to arrange the consolidated monthly pay to the Fire staff in accordance with para 5 above.
- 7. The Superintendent of Police/TS TRANSCO shall select a Leading Fireman (LFM) from the Retired fire personal who have represented to work in TS TRANSCO.
- 8. The Leading Fireman (LFM) personnel shall be kept under the control of the Superintendent of Police/TS TRANSCO/Vidyut Soudha/Hyderabad.
