## **ORDER**

- 1) In accordance with the provisions of AP Reorganisation Act, 2014, the erstwhile APERC granted Transmission Licence No. 01 of 2014 to the Licensee (Transmission Corporation of Telangana Limited) vide APERC proceedings No. APERC/Secy/160/2014, Dated 11.07.2014.
- 2) The TSERC had notified Regulation No.2 of 2016 (Levy of fees for various services rendered by the Commission) to be effective from 1st April, 2016 duly amending the Regulations 11 of 2013 & 1 of 2005 notified by the erstwhile APERC.
- 3) As per the provisions made under Clause (4)(2) of Regulation 2 of 2016, the Transmission Licensee should pay the Annual Licence Fee @ Rs.2000/- per MW of the Allocated Contracted Capacity as approved in the tariff order for the 4<sup>th</sup> Control Period (FY2019-20 to FY2023-24).
- 4) The Contracted Capacity approved by the TSERC vide Ref. (1) for TSTRANSCO For FY 2021-22 is 21,370.12 MW, accordingly, the Annual License Fee payable is Rs. 4,27,40,240=00 (Rupees Four Crore Twenty Seven Lakh Forty Thousand Two Hundred and Forty only).
- 5) Hence, TSTRANSCO hereby accords approval for payment of an amount of Rs. 4,27,40,240=00 (Rupees Four Crore Twenty Seven Lakh Forty Thousand Two Hundred and Forty only) towards Annual Licence Fee of the Transmission Licensee for FY2021-22.

- 6) The Pay Officer/TSTRANSCO/Vidyut Soudha/Hyderabad is authorized to draw the amount and arrange for payment by online transfer in to the account of the TSERC, A/c No. 34390770811, SBI Bazarghat branch, IFSC code: SBIN0005893.
- 7) The expenditure is chargeable to account head 076-103, Annual Licence Fee.
