ORDER:

1. The Chief Engineer/Rural has stated that during inspection of Circle office building by Higher officials, it was instructed to take up Construction of 2nd floor for providing accommodation to offices of AEE/Civil/Const/ Nalgonda, AEE/Civil/O&M/ Nalgonda, AEE/Const/ Nalgonda, Telecom wing and MRT wing as there is no accommodation available for these offices.
2. Accordingly, the Chief Engineer/Rural Zone has Submitted an estimate for the work of “Construction of 2nd floor over existing OMC Circle office Building at Nalgonda” at an estimated cost of Rs.62,73,000/- After scrutiny the value of work comes to Rs.61,22,060.00 (Rupees Sixty One Lakhs Twenty Two Thousand and Sixty Only).
3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TS Transco here by accords approval for taking up the work of “Construction of 2nd floor over existing OMC Circle Office Building at Nalgonda” for an amount of to Rs.61, 22,060.00 (Rupees Sixty One Lakhs Twenty Two Thousand and Sixty only) including NAC Corpus Fund and GST Provisions.
4. The work will be taken up after allocation of necessary capital budget (Non-Plan) and sanction of the estimate.
