ORDER:

1. The Superintending Engineer/Civil/Karimnagar has stated that, Nizamabad Circle Office was formed in the year 1996 and since then accommodating in a small quarter in the premises of 132/33 KV Sub-station Nizamabad. The quarter was constructed during construction of 132KV Sub-station Nizamabad long ago. In due course, the Circle is renamed as OMC Circle and expanded its jurisdictions as well as its staff with P\&G and Accounts Wing. The office becomes very much congested and quarter is affected by its aging factors as well as presence of predominant BC soils. The quarter is not serving the purpose even after several repairs and rectifications. Hence, the construction of New Office Building for Circle Office is necessitated for smooth functioning of the Superintending Engineer/OMC Circle /Nizamabad and to accommodate the entire staff of SE/OMC Circle/Nizamabad.
2. In view of the above, the Superintending Engineer/Civil/Karimnagar submitted an estimate for " Construction of circle office building (G+1) floors for O/o. SE/OMC/Nizamabad in the compound of 132/33KVSS Nizamabad" .
3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, T.S.Transco hereby accords approval for taking up the work of "Construction of circle office building (G+1) floors for O/o. SE/OMC/Nizamabad in the compound of 132/33KVSS Nizamabad" for an amount of to Rs.2,34,18,794.00 (Rupees Two Crores Thirty Four Lakhs Eighteen Thousand Seven Hundred and Ninety Four only) including NAC Corpus Fund and GST Provisions.
4. The work will be taken up after allocation of necessary capital budget and sanction of the estimate.
