**ORDER:**

The ceiling in the 4<sup>th</sup> and 5<sup>th</sup> floor corridors of A Block are fitted with Electrical cables, fire fighting system and other wiring. This is hazardous to the building. Hence, false ceiling is necessary. Therefore, it is proposed to provide False Ceiling in the Corridors of 4<sup>th</sup> & 5th Floors of Vidyut Soudha.

Accordingly, the Executive Engineer/Civil, BM has submitted an estimate for “Providing false ceiling to 4th & 5th floor corridors of A Block, Vidyut Soudha, Hyderabad “ for an amount of Rs.21,50,000/- (Rupees Twenty One Lakh Fifty Thousand Only).

After scrutiny with SSR 2017-18 and steel and cement rates of June'2018, the value of work comes to Rs. 20,92,020/- (Rupees Twenty Lakhs Ninety Two Thousand Twenty Only).

Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, T.S.Transco hereby accords approval for the work of “Providing false ceiling to 4th & 5th floor corridors of A Block, Vidyut Soudha, Hyderabad “ for an amount of Rs. 20,92,020/- (Rupees Twenty Lakhs Ninety Two Thousand Twenty Only) under capital funds of RMI.
