TSTRANSCO – Nurturing the spirit of entrepreneurship among SCs/STs, Waddera and Sagara (Uppara) Contract Cooperative societies and Individuals belonging to the said communities - Measures to promote participation in the works of all the Engineering Departments - Adopting the G.O.Ms.No.29, Dt.26.05.2017 for works in TSTRANSCO - Orders – Issued.

O R D E R :

In the ref. 1st cited, the Government of Telangana has issued orders for measures to promote participation of Co-operative Societies and individuals belonging to SCs/STs, Waddera and Sagara (Uppara) in works of all Engineering Departments stating that in order to nurture the spirit of entrepreneurship among various sections of society especially, among SCs/STs, Waddera and Sagara (Uppara) Societies and Individuals, after the Board of Chief Engineers suggested comprehensive measures to ensure greater participation of these communities in the nation building process as contractors.

In the reference 2nd cited, Special Chief Secretary to Government, Energy Department, Telangana Secretariat, Hyderabad has requested to implement the above G.O. in TS TRANSCO.

After careful consideration, approval is hereby accorded for implementation of G.O.Ms.No.29, Dated:26.05.2017, in regard to entrustment of works to SCs/STs, Waddera and Sagara (Uppara) Contract Co-operative Societies and individuals, for works in TS TRANSCO, duly following the Guidelines as below:

I. Registrations:

All the engineering departments in the State shall ensure hassle free registration to such societies and individuals depending upon their work experience under different categories of contractors. However, no work experience and Solvency Certificate need to be insisted for the purpose of registration of Contractors as Class-V eligible to take up works up to Rs.50 lakh as per GO Ms.No.66, I & CAD (Reforms) Department, Dt:20.04.15.

II. Exemption of EMD:

- i) The Labour Co-operative Contract societies of SCs/STs/Waderra/ Sagara will be exempted from payment of EMD to works costing up to Rs.50.00 Lakh.

- ii) The Individuals belonging to SCs, STs/Waddera/Sagara be exempted from payment of EMD to works costing up to Rs.20.00 Lakh.
- iii) However in order to provide level playing field to all, EMD will be recovered from running bills after expenditure of 25% of the concerned works. This will also inculcate the responsibility for completion of the works.

III. Works to be earmarked:

At least 15% of works may be earmarked to the individuals belonging to SC/ ST/ Waddera/Sagara contractors costing up to Rs.20.00 Lakh and SC/ ST/ Waddera/Sagara Labour cooperative societies up to Rs.50.00 Lakh on online e-procurement and all other methods of procurement.

IV. Number of works to be entrusted at any time:

- a. At a time single work will be given to the labour co-operative contract societies and individuals of SCs/STs/Waddera/ Sagara communities. No second work will be given unless the work on hand already entrusted to them is completed to the extent of 50% as certified by the concerned Executive Engineer.
- b. At any time, the total estimated cost of fresh works entrusted to labour Co-operative Contract Societies of SC/STs/Waddera/ Sagara should not exceed Rs.50.00 Lakh.
- c. Similarly, the total estimated cost of fresh works entrusted to individuals of SCs/STs/Waddera/Sagara will not exceed Rs.20.00 Lakh excluding the works on hand which are completed more than 50%.

V. Area of Operation:

The area of operation for the work taken up the labour Co-operative contract societies and Individuals belonging to SCs/STs/Waddera/ Sagara, would be the District in which they are registered for all departments.

Methodology:

- I. All the Chief Engineers/Suprintending Engineers & Executive Engineers shall ensure that any one work out of every seven such works within the range of Rs.20.00 lakh for individuals and Rs.50 lakh for societies are automatically earmarked for limited competition among SCs/ STs/ Waddera/ Sagara, (Uppara) communities at the e-procurement platform. ITE&C Department shall take necessary steps to modify the software for this purpose. In exceptional cases of offline tender, a register will be maintained at the level of each tender inviting authority.

- II. In the NITs of such earmarked works, it may be mentioned under name of work that "Invited under earmarked works- SCs/ STs/ Waddera/ Sagara (Uppara) societies and individuals belonging to such communities as the case may be, are only eligible to participate".
- III. Based on the nature and value of works, the concerned Chief Engineers/Suprintending Engineers & Executive Engineers may decide and earmark any one work (i.e., costing up to Rs.50.00 lakh for societies and Rs.20.00 lakh for individuals) to SCs/STs/ Waddera/ Sagara (Uppara) communities within a cluster of 7 works.
- IV. If no response is there in from SCs/STs/Waddera/ Sagara (Uppara) communities/Individuals for the earmarked works, the same may be invited under General category in the 2nd call.
- V. It goes without saying that entrepreneurs of these categories may continue to participate in all other tenders subject to their eligibility.
