ORDER:

1. The Chief Engineer/Transmission has transmitted an estimate for the work of “Water Supplying arrangements to Earth Pits and Metal Spreading to 132KV yard at Durshed 220KV SS in Karimnagar District for an amount of Rs.27,63,393.00 excluding taxes.
2. The estimate is scrutinized by Chief Engineer/Civil with SSR 2017-18 with GST and provision for NAC Corpus Fund and cement & steel rates for the month of August,2018. The total value of the estimate worked out to Rs.31,26,727.00 (RupeesThirty One Lakhs Twenty Six Thousand Seven Hundred and Twenty Seven only).
3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, T.S.Transco hereby accords approval for taking up the work of “Water Supplying arrangements to Earth Pits and Metal Spreading to 132KV yard at Durshed 220KV SS in Karimnagar District” for an amount of to Rs.31,26,727.00 (Rupees Thirty One Lakhs Twenty Six Thousand Seven Hundred and Twenty Seven only) including NAC Corpus Fund and GST.
4. An amount of Rs. 25.00 Lakhs was allotted for providing of Metal Spreading and etc., works at 220KV Durshed SS, Karimnagar OMC, under RMI Scheme Vide T.O.O Chief Engineer (Transmission) Ms.No.146, dt.07-10-17. The Balance amount of Rs.6.27Lakhs will be allotted from Non-Plan Capital Budget against N-18-01\_5111 of Superintending Engineer/OMC/Karimnagar.
