ORDER:

- 1. The Chief Engineer/Karimnagar Zone has informed that the 132KV Mancherial Substation was charged during the year 1985. Mancherial is an industrial area and uninterrupted power supply to various feeders is essential. Since charging, Metal spreading, construction of cable duct, culverts and retaining wall are not provided. Passage of vehicles over the cables may cause damage to the cables. Grass growth in the Switchyard may lead to fire accidents. Hence, it is necessitated to construct cable duct, culverts, retaining wall and metal spreading.
- Hence, the Chief Engineer/Karimnagar Zone has transmitted an estimate for Providing of Metal spreading, Construction of Cable duct, Retaining wall and culverts at 132 KV Substation Mancherial in Mancherial District for an amount of Rs. 42,03,737.00.
- 3. The estimate is scrutinized by Chief Engineer / Civil with SSR 2018-19 and total value of work comes to Rs.42,55,596.00(Rupees: Forty Two Lakhs Fifty Five Thousand Five Hundred and Ninety Six only). Administration approval for an amount of Rs.35.00 Lakhs for Providing metal spreading and water supply arrangements works in the Switchyard of 132KVSS Mancherial in Adilabad circle during FY: 2018-19 is available in T.O.O.CE(Transmission) Ms.No.146, dt.07.10.17 under RMI scheme. Balance amount of Rs. 7,55,596.00 can be met from an amount of Rs. 30 Lakhs allotted to the Labour component of Line works and SS works of RMI budget to the Superintending Engineer/OMC/Adilabad(5122) during the FY: 2017-18, as per re-allocation all **OMC** circles to and Telecom circles vide Lr.No.CE(Tr.)/D.No.767/17, Dt: 31-10-17.

Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TSTransco hereby accords approval for taking up the work of "Providing of Metal spreading, Construction of Cable duct, Retaining wall and Culverts at 132 KV and 33 KV Switchyards at 132 KV Substation Mancherial in Mancherial District" for an amount of Rs.42,55,596.00(Rupees: Forty Two Lakhs Fifty Five Thousand Five Hundred and Ninety Six only).
- 5. The work shall be taken up after allocation of necessary RMI budget and sanction of the estimate.
