ORDER:

1. The Chief Engineer/Zone /Karimnagar has informed that there is no internal road to the power transformers and also there is no CC road from Highway to Switchyard area at 220 KVSS Dichpally. There are ruts and undulations which are causing much inconvenience while attending emergencies and break downs. The higher authorities have instructed to take up the CC road work immediately. It is also proposed to construct retaining wall for 220KV transformers bay.
2. The Chief Engineer/ Karimnagar Zone has transmitted an estimate for Construction of Retaining wall and Laying of CC Road at 220 KV Sub-Station, Dichpally in Nizamabad District for an amount of Rs. 31,73,194.00.
3. The estimate is scrutinized by Chief Engineer / Civil with SSR 2018-19 with cement & steel rates for the month of January 2019, with GST, NAC Corpus Fund and Provision of Seigniorage charges and total value of work has come to Rs.31,16,905.00(Rupees: Thirty One Lakhs Sixteen Thousand Nine Hundred and Five only).
4. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TSTransco hereby accords approval for taking up the work of “Construction of Retaining wall and Laying of CC Road at 220 KV Sub-Station, Dichpally in Nizamabad District” for an amount of Rs. 31,16,905.00(Rupees: Thirty One Lakhs Sixteen Thousand Nine Hundred and Five only).
5. The work shall be taken up after allocation of necessary Non-Plan Capital budget and sanction of the estimate.
