ORDER:

# 1. The Chief Engineer/Rural zone has submitted an estimate for an amount of Rs. 56,35,000/- (Rupees Fifty Six Lakhs Thirty Five Thousand only) for the subject work stating that the substation does not have cable duct from the beginning and there is also no road in the substation.

- 2. Further, The Superintending Engineer/Rural Zone has submitted that the 220/132kV SS at Sadasivpet was commissioned on 11.10.2010. The total area of the 220kV Switchyard is 5400Sqm, for which the metal spreading was not provided at the time of charging, thereby resulting in the growth of grass/weed, which may cause fire and other accidents. As there is no road in the SS, provision for WBM and CC road, watering arrangements to the earth pits and cable duct is also provided in the estimate.
- 3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TS Transco here by accords approval for taking up the work of "Laying of CC Road, Construction of cable duct, Metal spreading and water supply arrangements to earth pits at 220/ 132 KV SS Sadashivpet in Sangareddy District" for an amount of Rs. 53,04,861.00 (Rupees Fifty Three Lakhs Four Thousand Eight Hundred Sixty One only) including NAC Corpus Fund and GST Provisions.
