ORDER:

1. The Chief Engineer/Civil submitted that, approval was accorded to take up renovation of General toilets in A - Block in a phased manner. Accordingly renovation of toilets was taken up in the Ground floor of A - Block and the work is completed, as per the T.O.O cited at reference.
2. Now, it is proposed to take up renovation of General toilets in the 4th and 5th floor of A- Block, Vidyut Soudha for 6 Nos of Gents toilets and 4 Nos of Women's toilets. Also two pipe ducts, carrying CI pipes from all the toilets running from 6th floor to the ground floor of A – Block, Vidyut Soudha are proposed to be replaced with CPVC pipes.
3. Executive Engineer/Civil/Vehicle & Building Maintenance/Vidyut Soudha has submitted an estimate for "Renovation of toilets in 4th & 5th floors of A - Block, Vidyut Soudha, Hyderabad".
4. The estimate is scrutinized with latest SOR 2018-19 with the cement and steel rates for the month of June - 2019, with GST, NAC Corpus Fund and Provision of Seigniorage charges and the total value of work comes to Rs. 45,38,435.00 (Rupees Forty Five Lakhs Thirty Eight Thousand Four Hundred and Thirty Five Only)
