### **ORDER:**

- The Chief Engineer/Rural zone has submitted an estimate for "Construction of new compound wall, CC Road and extension of control room for Bay extensions at 132/33 kV SS Narayankhed in Sangareddy District" for an amount of Rs.59,00,000/- and Rs.35,00,000/- respectively stated that the 132/33kV SS at Narayankhed was commissioned on 18.08.1994, the total area of the SS is 3.31 acres and the existing compound wall is in a very bad condition and also collapsed at some places due to black cotton soil condition and there is no compound wall between 33/11 KV substation and 132/33KV substation. The existing chain link fencing at entrance gate is also damaged and there is no space available to accommodate new panels for second circuit from 132kV Narayankhed to 132kV Zaheerabad in the existing Control room and also approach road with WBM is laid at the time of commissioning. Now it is proposed to lay CC road.
- 2. The estimate is scrutinized with the latest SSR 2018-19 and May'19 cement and steel rates, and the value of work after scrutiny comes to Rs.97,05,064.00 (Rupees Ninety Seven Lakhs Five Thousand Sixty Four only) inclusive of all taxes and seiginorages
- 3. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TS Transco here by accords approval for taking up the work of "Construction of new compound wall, CC road and control room to bay extension at 132/33kV SS Narayankhed in Sangareddy District" for an amount of Rs.97,05,064.00 (Rupees Ninety Seven Lakhs Five Thousand Sixty Four only) including NAC Corpus Fund and GST Provisions.

- 4. The work will be taken up after allocation of necessary capital budget (Non-Plan) during the financial year 2019-20.
- Chief Engineer/Civil/TSTRANSCO is authorized to take up the above work.
