ORDER:

1. The canteen is available in the premises of Vidyut Soudha to provide Tea, Tiffin, meals and snacks to the staff of Vidyut Soudha. This building is constructed long back. Painting is fade up due to aging. The MS windows are provided, which are totally damaged and not in-service. Ventilators provided with open. Due to this birds, flies, mosquitoes entering into the kitchen. Kitchen plat form completely damaged, smoke is spreading in the canteen total area. Hence the renovation to the canteen is necessitated.
2. Accordingly, the Superintending Engineer/Civil/400 KV Projects has submitted an estimate for an amount of Rs.14, 99,883.00 (Rupees Fourteen Lakhs Ninety Nine Thousand Eight Hundred and Eighty Three Only).
3. The above estimate is scrutinized with SSR 2020-21, Steel Cements rates for the month of July-2021 and the value of work comes to Rs.15,48,014.00 (Rupees Fifteen Lakh Forty Eight Thousand and Fourteen Only), which is inclusive of GST@ 18%.
4. Under the circumstances explained by the Chief Engineer/Civil and after careful consideration, TS Transco hereby accords approval for the work of “Renovation of Canteen in the premises of Vidyut Soudha, Hyderabad” for an amount of Rs.15,48,014.00 (Rupees Fifteen Lakh Forty Eight Thousand and Fourteen Only), which is inclusive of GST@ 18% under Non-plan Capital budget.
