ORDER:

1. It is to submit that the Chief Engineer/SLDC/Vidyuth Soudha stated that SLDC is operating 24x7 at 6<sup>th</sup> floor “A” Block. There is no emergency exit for the SLDC in case of fire, earth quake etc. and requested to provide an emergency exit to the SLDC room. And also stated that women employees are working in SLDC shift in 6<sup>th</sup> floor, there is no separate toilets are available to them and the existing toilets are got damaged and not in pleasant state and requested to renovate the toilets in SLDC.
2. In this regard Superintending Engineer/Civil/400 KV Projects has submitted an estimate for an amount of Rs.22,03,880.00 (Rupees Twenty Two Lakhs Three Thousand Eight Hundred and Eighty Only).
3. The estimate is scrutinized and the value of work comes to Rs.23,40,746.00 (Rupees Twenty Three Lakhs Forty Thousand Seven Hundred and Forty Six only), which is inclusive of GST@ 18%.
4. Under the circumstances explained by the Chief Engineer/Civil and after careful consideration, TS Transco here by accords approval for taking up the “Providing MS Stair Case for Emergency exit for SLDC and Renovation of Toilets at SLDC, 6<sup>th</sup> floor in Vidyut Soudha, Hyderabad” for an amount of Rs.23,40,746.00 (Rupees Twenty Three Lakhs Forty Thousand Seven Hundred and Forty Six only) under Non-planned Capital budget.
5. Chief Engineer/Civil/TS Transco is authorized to take up the above work.
