## ORDER :

In the ref. 1st cited, the Government of Telangana has issued orders for establishment of Telangana Haritha Nidhi (Telangana Green Fund) in the State in order to expand, enhance and to deepen the fruits of the massive plantation activity and to provide sustainability to the ongoing Telanganaku Harithaharam in the long time.

In the reference 2<sup>nd</sup> cited, Special Chief Secretary to Government, issued certain instructions stating that “work contract of all the Engineering Department & Corporations in the State @ 0.01% of the value of the contract and ensure the stipulated deduction & remittance into Telangana Haritha Nidhi”.

After careful consideration, TSTransco accorded approval for implementation of G.O. Ms. No. 17, (Finance(TFR) Dept.), Dt. 18.02.2022 duly following the Guidelines as below:

1. Implementation of Telangana Haritha Nidhi (Telangana Green Fund) @ 0.01% for the total value of the contract.
2. Not to provide any provisions in the estimates towards Telangana Haritha Nidhi.
3. For all the future TSTransco work contracts, 0.01% of the total value of the contract is to be deducted from the work contract bills and to be remitted to the Telangana Haritha Nidhi.
4. All the Drawing and Disbursing Officer's/ Accounts Officers/ Pay Officers concerned shall accordingly deduct Telangana Haritha Nidhi contribution and shall credit the same into the following Telangana Haritha Nidhi Account:
