## **ORDER:**

For the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha, permission was issued to engage retired fire personnel on contract basis for one year vide reference 1<sup>st</sup> cited. Consequently, Guidelines for appointment and payment procedure were issued vide reference 2<sup>nd</sup> cited. The contract of six months for engaging retired fire personnel for the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha is expired on 09<sup>th</sup> August' 2022, vide references 11<sup>th</sup> & 12<sup>th</sup> cited.

- 2. Fire safety of Vidyut Soudha building and its premises is of utmost importance. Fire Personnel are essential to prevent fire accidents and maintain the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha.
- 3. In view of the above and after careful consideration, approval is hereby accorded for engaging retired fire personnel on contract basis for six (6) months from 10<sup>th</sup> August' 2022 for the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha. The upper age limit for engaging retired fire personnel may be taken as 67 years for interim arrangement only.

- 4. The total financial commitment is Rs 8,70,000/-. Further 1 No Station Fire Officer (SFO) will be paid consolidated monthly pay of Rs 25,000/- (Rupees Twenty Five Thousand only) and 6 No Leading Firemen(LFM) will be paid consolidated monthly pay of Rs 20,000/- (Rupees Twenty Thousand only) for each person.
- 5. The total financial commitment of Rs 8,70,000/- per annum towards consolidated monthly pay of the Fire Staff (1 No Station Fire Officer & 6 No Leading Firemen) shall be shared equally by TSTRANSCO & TSGENCO.
- 6. The Fire Staff (1 No Station Fire Officer & 6 No Leading Firemen) are kept under the control of the Superintendent of Police(Vigilance), TS Transco, Vidyut Soudha, Hyderabad. The Superintendent of Police (Vigilance), TS Transco, VS, Hyderabad is further directed to submit the Change Return in respect of the above Fire Staff to the Pay Officer, TS Transco, Vidyut Soudha, Hyderabad to arrange the Consolidated Monthly Pay.
- 7. The Consolidated Monthly Pay paid to the Fire Staff (1 No Station Fire Officer & 6 No Leading Firemen) shall be shared equally by TSTRANSCO & TSGENCO.
- 8. The Pay Officer, TSTransco, Vidyut Soudha, Hyderabad is directed to arrange the Consolidated Monthly Pay to the Fire Staff in accordance with above para 7.
- 9. All other terms & conditions as communicated vide references cited remain unaltered.
