PROCEEDINGS:

- 1. Commissioner (P&D, Godavari Basin) of I&CAD/Hyderabad vide letter cited under ref(1), has informed that a load of 41MW were added to existing package no.21 i.e. 16MW at New Manchippa and 25MW at Mentrajpally respectively in Nizamabad district under Kaleshwaram lift Irrigation Scheme due to re-engineering for pressurized piped Irrigation system at the subject location.
- **2.** The Power requirement details as furnished by I&CAD required at New Manchippa Pump house and at Mentrajpally Pump House are as follows:

department, JalaSoudha, Hyderabad for taking up the works by TS TRANSCO.

Vidyut Soudha/Hyderabad.
