**ORDER:**

In the references 5<sup>th</sup> & 6<sup>th</sup> cited, TSTRANSCO issued orders for extending other allowances/benefits to the Artisans wherein it was ordered to pay T.A & D.A to the Artisans who are performing field duties, as per their eligibility (Basic Pay) for official tours and working instructions were issued for payment of Daily Allowance & Travelling Allowance to Artisans.

2. In TSPCC Meeting held on 22.06.2022 the issue of TA, DA and Lodging Charges in respect of Artisans of TSTRANSCO & TSDISCOMs who participate in Inter Circle Tournaments within/outside of Telangana State in All India Sports Control Board Tournaments was discussed and decided to extend the TA, DA & Lodging Charges to the Artisans as per their eligibility.

3. After Careful Consideration, the TSTRANSCO hereby issues the following orders.

- Pay the TA & DA to Artisans who participate in inter-circle/state tournaments as per eligibility (Basic Pay) on par with official tours as per orders issued vide T.O.O.Ms.No.1073, Dt.27.05.2021
- Reimbursement of Lodging Charges to Artisans at various places within the State and outside the State on official duty is eligible on par with Grade-III Employees of TSTRANSCO for reimbursement of lodging charges actually paid by them subject to the maximum amounts as indicated below, subject to conditions that a certificate is produced by concerned Artisan that official Accommodation is not available and on his production of original receipt from Lodging House.
