O R D E R :

In the letter cited the CE/Warangal Zone informed that Sri A Madhava Rao, Artisan Grade-IV (ID- TSTRSEOMCOKMM03510), DOB: 03.07.1970 S/o.Raghavaiah while working at CBD Gang/TLO/Budidampadu expired due to electrocution while on duty on 06.08.2020. Hence, requested for sanction of compensation amount and other terminal benefits

2. As per the orders issued vide T.O.O. Ms.No.150, dt.18.7.2018 *compensation is admissible under the Employee Compensation Act, 1923; OR the compensation as arrived at under the Employee Compensation Act,1923 to the Artisans in case of fatal accident while on duty.*

3. Accordingly, TS Transco accorded sanction a sum of Rs.11,48,175/- (Rupees Eleven Lakhs Forty Eight Thousand One Hundred and Seventy Five only) as workmen compensation towards final settlement to Legal heir of Late Sri A Madhava Rao, Artisan Grade-IV (TSTRSEOMCOKMM03510) while working at CBD Gang/TLO/Budidampadu and expired due to Departmental Fatal Accident on 06.08.2020.

4. The Chief Engineer/Warangal Zone/TSTRANSCO is requested to take necessary action subject to the following conditions.

- The payment should be made without admitting any legal liability.
- An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
- Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.

5. This order issues with the concurrence of JMD (Finance, Comml., & HRD) vide Regd.No.2099, dt.28.05.2021.
