The Chief Engineer(IT) has submitted Budgetary proposals for Capital Works and R&M Works in respect of IT Department for the FY 2020-21 towards procurement of various IT equipment and other associated equipment, Procurement of Additional SAP Pay Roll Licenses (for Artisans), Procurement of MS Office Software, Windows 10 Operating System software etc., Procurement of Web Application Firewalls, Gateway Security Device, Switches, Servers, Software's etc for Local Area Network in Vidyut Soudha, Onsite support services for TSTRANSCO Data centre, Reloading/Recycling of Printer Toner Cartridges and AMC of Desktop and its peripherals etc.,
