ABSTRACT

EXTENSIONS – Extension of Power Supply at 132kV level for a C.M.D of 44.88 MVA to Pumping Station at Hathighat(V), Jainath(M) for a load of 38.15 MW under Chanaka - Korata Lift Irrigation Scheme in Adilabad District – **Bulk Load Works - Revised Administrative Approval** – Accorded.

PROCEEDINGS:

- 1) Chief Engineer/Projects/Adilabad vide letter dated 19.07.2016 informed that Government of Telangana has decided to take up Chanaka-Korata Barrage, Pumping Station at Hathigat(V), Jainath (M) of Adilabad District and requested for extension of power supply.
- 2) Chief Engineer/Projects/Adilabad vide letter dated 30.01.2017, further submitted that power required for the pumping station is about 38.15 MW.
- Accordingly, Administrative approval was accorded vide T.O.O. Ms.No.12, dtd.15.05.2017 **as a single TOO for both Bulk Load and DC Works** for extension of power supply at 132kV level for a C.M.D of 44.88 MVA to Pumping Station at Hathighat(V), Jainath(M) for a load of 38.15 MW under Chanaka Korata Lift Irrigation Scheme in Adilabad District, duly considering the approval for 10% Overhead Charges in 15th Board Meeting (dt:18.11.2016) and Scheme Cost was communicated to I&CAD Department.
- 4) Now the estimated cost of the scheme is revised as two separate T.O.O.'s are to be issued in order to separate **Bulk Load Works (up to metering arrangement) and Deposit Contribution works** for demarcation and capitalization of assets of TSTRANSCO up to metering arrangement.
- After careful consideration, TSTRANSCO approves the revised Scheme at a cost of Rs.2921.69 Lakhs (Rupees Two Thousand Nine Hundred Twenty One Lakhs and Sixty Nine Thousand only) including 10% overhead charges against Bulk Load Works from I&CAD Department, Telangana and the details are as follows:

- 6) "In exercise of the powers conferred under section 164 of the Electricity Act,2003 Central Act No.36 of 2003, the Government of Telangana (vide G.O.Ms.No.115, Dt.7.10.2003) conferred upon the Transmission Corporation of Telangana Limited, the Transmission supply licensee in the state of Telangana, Northern Power Distribution Company of Telangana Limited and Southern Power Distribution Company of Telangana Limited the distribution and retail supply licensee or their authorized representatives to have the powers for placing of the electric supply lines or electric plant for the transmission of electricity or for the purpose of telephonic or telegraphic communications necessary for the proper co-ordination of works that a telegraphic authority possessed under the provision of the Indian Telegraph Act, 1885 (Central Act 13 of 1885)."
- 7) The sanction accorded in Para No.5 above is subject to instructions issued by the TSTRANSCO on release of services and tariff as may be in force from time to time. This approval **supersedes** the approval given vide T.O.O under reference(3) cited above.
- 8) The works are under the scope of Chief Engineer/LIS/TSTRANSCO/VS/Hyderabad.
- 9) An amount of **Rs.2921.69 Lakhs** shall be collected as Service Line charges and Development Charges from Engineer in Chief / I&CAD/ Projects /Karimnagar for carrying out the works by TSTRANSCO.

- 10) In addition to the scheme amount, Security Deposit Charges of Rs.448.82 Lakhs i.e., Rs 1000/- per KVA and Service Connection Charges of Rs.30,000/- is payable to TSNPDCL at the time of Release of Service Connection by I&CAD Department, Govt., of Telangana.
- 11) The order is issued with the concurrence of Joint Managing Director (Finance, Comml., & HRD)/ TSTRANSCO vide Regd.No.4483 , dated 26.11.2020.
