ORDER:

TSTRANSCO after careful consideration hereby appoints Sri <u>D.Abhinav Rao</u>, Advocate-on-Record, New Delhi as "Standing Counsel" for TSTRANSCO/TSPCC at New Delhi to represent before Hon'ble Supreme Court of India, APTEL, CERC and other Forums/Commissions/Tribunals at New Delhi with the following <u>terms and conditions</u>:

The Standing Counsel shall:

- a) Appear before Hon'ble Supreme Court of India, Appellate Tribunal for Electricity (APTEL), Central Electricity Regulatory Commission (CERC) and other Courts, Forums, Tribunals, Commissions, etc. at New Delhi on behalf of TSTRANSCO/TSPCC in all cases or classes of cases where the TSTRANSCO/TSPCC is a party or its interests are involved.
- b) Prepare affidavits, counter affidavits, petitions, appeals and all other connected documentation for legal proceedings on behalf of TSTRANSCO/TSPCC.
- c) Prepare, settle and scrutinize agreements, contracts, deeds and other documents of legal and / or regulatory nature as may be referred to him by TSTRANSCO/TSPCC or its functional heads.
- d) If required, render all assistance to the Senior or Special Counsels, Advocate General of the State Government, who may be engaged in a particular case before the Hon'ble Supreme Court, APTEL, CERC, etc at New Delhi.
- e) Whenever necessary he shall engage Senior Counsel with the prior approval of TSTRANSCO/TSPCC
- f) To effectively coordinate with concerned officials in the particular case or cases for timely filing of Petitions / Affidavits / Counter Affidavits before Hon'ble Supreme Court, APTEL, CERC, etc.
- g) Tender advice and opinion to the TSTRANSCO/TSPCC and its functional heads on matters involving legal implications as may be referred to him.
- h) Keep TSTRANSCO/TSPCC informed of the important developments in the cases from time to time particularly with regard to drafting, filing of papers, dates of hearing of the case, order of the court on the date of its pronouncement, supplying copies of judgments, etc.
- i) Furnish to the Corporation quarterly statement about the cases represented by him before the Hon'ble Supreme Court of India, APTEL, CERC, etc
- j) Perform such other work of a legal and / or regulatory nature as may be entrusted to him by the Corporation from time to time.
- k) To pro-actively monitor all legal issues/judicial cases and maintain follow up of all cases pertaining to TSTRANSCO/TSPCC to ensure timely and effective action.

- 2. The Standing Counsel during the period of his tenure will be paid monthly retainer fee, other charges/fee and expenses as mentioned in the annexure enclosed to this order.
- 3. TSTRANSCO/TSPCC reserves its right to terminate the services of Sri D.Abhinav Rao, AOR as Standing Counsel to TSTRANSCO/TSPCC, at any time without prior notice.
- 4. The monthly retainer fee and applicable taxes (if any), shall be equally shared by TSTRANSCO & TSDISCOMS/TSPCC.
