In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of professional fee of **Rs.4,00,000/-** (Rupees Four Lakhs only) to **Sri G.Vidyasagar, Senior Advocate, Hyderabad** towards fee for conference on 08-07-2018 and appearance on 09-07-2018 on behalf of Telangana Power Utilities on 07.05.2018 before Hon'ble Supreme Court of India in SLP (C) No.9243/2018 and batch filed by T.S power utilities with regard to final bifurcation of employees between T.S and A.P power utilities. Sanction is also accorded for payment of **Rs.72,000/-** (Rupees Seventy Two Thousand only) towards **GST @18%** on the fee sanctioned to the Senior Advocate.

The Pay Officer/TSTRANSCO, Vidyut Soudha, Hyderabad is requested to arrange payment of **Rs.4,00,000/-** (Rupees Four Lakhs only) sanctioned in Para.1 above by cheque in favour of **“Sri G.Vidyasagar, Senior Advocate, Hyderabad”**. It is also requested to arrange for remitting the **GST of Rs.72,000/-** (Rupees Seventy Two Thousand only) to **Service Tax Department, Govt of India**.

3. As the Senior Advocate appeared on behalf of T.S power utilities before Hon'ble Supreme Court in the said matters, the fee payable along with applicable GST shall be shared among TSTRANSCO, TSGENCO, TSSPDCL & TSPNPDCL as detailed below:

5. The Executive Director (Finance), TSTRANSCO, Vidyut Soudha, Hyderabad is also requested to ensure that the reimbursement of above allocated amounts are received from the respective TSDISCOMs & TSGENCO.
