The Chief Engineer / Rural Zone has submitted the proposal for 2nd circuit stringing on existing 132 kV DC/SC line from 220/132/33 kV SS Chegur to 132/33 kV SS Kothur in Rangareddy District to meet the emergency & N-1 contingency.

- The Chief Engineer / Power systems has conducted the load flow studies and communicated the study report stating that, “considering line loadings, system EHT losses, to meet any emergency condition / (N-1) contingency and to avoid supply interruption to industrial feeders at 132 kV Kothur SS, stringing of 2nd circuit on existing 132 kV DC/SC line from 220/132/33 kV Chegur SS to 132/33kV Kothur SS is found to be technically feasible”.
- The Chief Engineer/ Telecom has furnished the detailed cost estimate for providing of Optical Fiber Communication facility to the proposed line for an amount of Rs.5.00 Lakhs
- After careful consideration, TSTRANSCO accords administrative approval for the above scheme at a total cost of Rs.3.39 Crores including IDC considering latest approved material / equipment rates with 10% price escalation & GST @ 18% as per the break up detailed below.
