In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of professional fee of **Rs.3,30,000/-** (Rupees Three Lakhs and Thirty Thousand only) to **Sri V.Giri, Senior Advocate, New Delhi** towards fee for appearance in the matter SLP(C).No.1322-1323/2019 filed by Mr. K.
